a. FY 2021-22 Budget Study Session - Operating, Capital & Cash Flow Budgets – Sandra Ormonde, Chief Executive Officer

CEO Ormonde reviewed in draft form the operating budget, capital budget and statement of cash flows with the Board. It was noted that these projections do not include Evolutions. Discussion was had regarding Line item 56 from the capital budget, Tower, in whether or not to expend funds to landscape the Cherry Street frontage or invest monies into the development of a new building for doctor offices. Ormonde advised the parking lot along Cherry Street will be placed in the next budget year. In reference to Line item 60, it was requested by Northcraft to pull Gym HVAC from the capital budget while he investigates energy options for Evolutions. Staff will bring this item to the Board's regular meeting on August 25 for further review.
