AT FRESNO, IN THE EASTERN DISTRICT OF CALIFORNIA:

The Application for Order Shortening Time on Motion on this matter was brought before this Court for its consideration on an ex parte basis as follows:

The Court having reviewed the Application and Declaration of Riley C. Walter and having determined that good cause exists for granting the Application, now therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

1. The Application is granted.
2. The period of notice is reduced.
3. The specially set hearing shall be set to take place as follows:

a) Location: United States Bankruptcy Court,
2500 Tulare Street, Fresno, CA 93721
Courtroom 13

b) Date: August 2, 2018 at 9:30 a.m.

4. The Debtor shall give notice only to Adventist Health West dba Adventist Health, California Department of Public Health, all secured creditors and counsel, trustees on bonds issued by the Debtor, all persons having requested special notice, the twenty largest unsecured creditors, all persons whose leases and contracts are being assigned, all taxing authorities, the Debtor, and the U.S. Trustee's Office by July 20, 2018.¹

5. Objections to the emergency borrowing Motion may be made up to the commencement of the hearing. Objections to the Transaction described in the Motion may be made up until one day prior to the final hearing.

6. FRBP 4001(c) provides that a motion to obtain credit be accompanied by a copy of the agreement. The subject motion herein calls for approval of several agreements related to the overall transaction including the credit agreement, security agreement, management services agreement, asset purchase agreement, lease, and

1 other documents related to the transaction. The agreements comprise approximately
 2 250+ pages of documents and the documents are summarized by their material terms
 3 within the motion. The Debtor requests that it be allowed to reference each document
 4 including the credit agreement by reference to a publically accessible website
 5 containing the final or nearly final version of each definitive document, and this be
 6 permitted in lieu of the actual service of the credit agreement and other exhibits.

7 7. The Debtor shall give a notice to all creditors and parties in interest by July
 8 20, 2018 describing the general nature of the Transaction, the relief sought and the
 9 location for access to the Motion and definitive documents on a publically accessible
 10 website.
